The property enjoys convenient dual access from the R736 and benefits from extensive frontage onto this public road.

The lands are well laid out in neat divisions and are currently under tillage, reflecting their excellent quality and productivity. Suitable for a wide range of agricultural enterprises, the holding offers fertile ground in a strong farming district. The elevated setting also provides stunning views over the surrounding Wexford countryside.

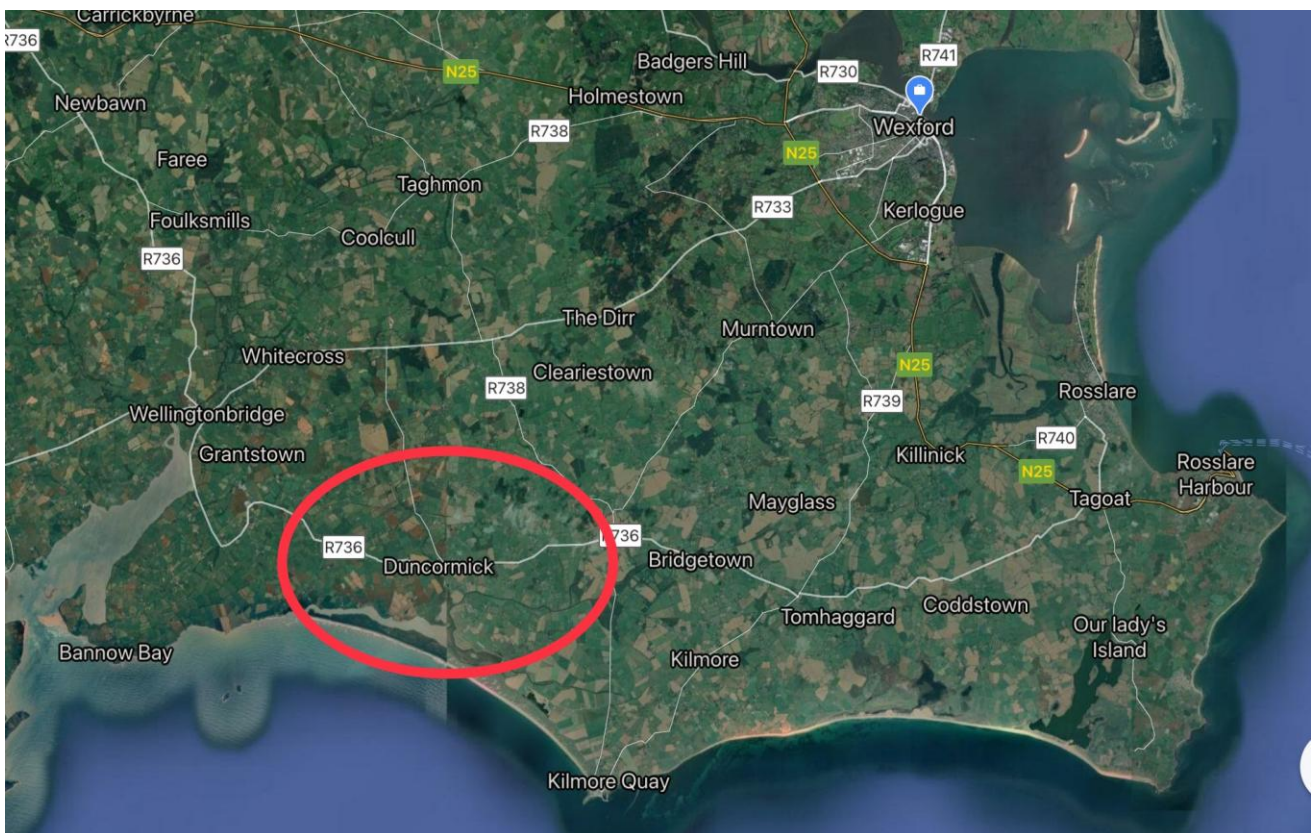

Wexford is the County Town with an urban population in the region of 21,524 people – (Source: CSO Census 2022). The results of Census 2022 show that County Wexford’s population has seen a rise of 9.7% to 163,919 since April 2016. At the time of the previous census County Wexford recorded a population of 149,425. This represents an increase of 14,494 people in 6 years. This is well above the national average, as the Central Statistics Office (CSO) has revealed that over the same period, Ireland’s population grew by 8% from 4,761,865 to 5,149,139.

Wexford has become an increasingly popular location to live, as people seek to escape the crowded capital, and this has combined with an increasing trend towards working from home. Wexford saw one of the highest levels of inward migration since 2016, with 9,487 people opting to move here. It was by far the highest in the south-east, with Waterford gaining 7,564, Carlow 2,807 and Kilkenny 1,756. In fact, Wexford saw the fifth highest number for estimated net migration in Ireland.
